## Washout, cleaning and disinfecting in accordance with AWWA C652

Regular conditions assessments, washouts and chemical cleanings should be part of the preventative maintenance of any water storage tank. They keep the tank in like-new condition, improving the return on your large capital investment while lowering related operation and maintenance costs.

## A comprehensive approach

### Tank Condition Assessment

We visually inspect the interior/exterior of the tank. We can use drones to safely inspect elevated storage tanks and remotely operated underwater vehicles (ROVs) to inspect the interior of tanks that can not be drained without disrupting water supply. If necessary our personnel can quantify the specific causes of organic and inorganic deposits through surface testing to recommend a targeted remediation solution.

### Reporting and documentation

After each inspection, we provide a report of our findings to assure compliance with state regulations. Our Condition Assessment Report gives an overview of the safety, structural, sanitary, security and coatings conditions of the tank so no potential maintenance issue is overlooked.

### Washouts and Chemical cleanings

Periodically draining and cleaning the inside of a tank eliminates mineral buildup and biofilm growth, and helps maintain a high level of water quality. We use patented NSF certified technologies for chemical cleanings and all washouts are performed in compliance with all applicable OSHA safety regulations including confined space.
